

# **REFEREES CODE OF CONDUCT**









# ZIMBABWE FOOTBALL ASSOCIATION REFEREES STANDING ORDERS

(To Be Read in Conjunction With The Zimbabwe Football Association Referees Code of Conduct)

## 1.0 INTRODUCTION

This Code provides Zimbabwe Football Association Referees, Instructors and Assessors with an indication of the standards of conduct and ethical behaviour expected of them. Any breaches of this Code should be reported to the Zimbabwe Football Association and their Referee Department. Zimbabwe Football Association will then consider appropriate action including but not limited to non-appointment to matches, deregistration or suspension.

#### 2.0 ETHICS

- 2.1 Perform your duties as a Referee/Assessor/Instructor without bias and maintain the highest standards of integrity and honesty. These standards shall be maintained in associated off-field activities.
- 2.2 Treat everyone equally, regardless of their disability, gender, ethnic origin, cultural background, religion, age and political affiliation.
- 2.3 Conduct yourself with dignity on and off the field. Do not act in a manner that brings yourself, your colleagues or ZIFA into disrepute.
- 2.4 Do not gamble, or encourage any other person to gamble, on a football match with which you are associated.
- 2.5 Do not referee matches where you have a potential conflict of interest. Ensure you make conflicts of interest, including family relationships to players, known to ZIFA and the Referees Appointments Sub-Committee.
- 2.6 Treat fellow Referees/Assessor/Instructors with respect. Negative comments and criticism about or towards another Referees/Assessor/Instructors or ZIFA, the Referee Department, verbal or written including on social media, is prohibited. Comments and criticism should be communicated to ZIFA Referee Department in a normal channel.



#### 3.0 CONDUCT STANDARDS

- 3.1 Be honest, consistent, objective, impartial and courteous when applying the Laws of the Game. You must resist any influence from protests on the part of participants or spectators of the game.
- 3.2 Be physically and mentally fit to meet the required standards to Referee or Assess the match you are assigned to. This includes passing fitness test requirements for Referees and relevant evaluations for Assessors and Instructors as required by ZIFA.
- 3.3 Maintain a smart appearance both on and off the field.
- 3.4 Your knowledge of the Laws of the Game and competition rules must be up-to-date and thoroughly understood, including any recent amendments.
- 3.5 Your responsibility is to your appointment of the day. Do not undertake other appointments earlier on the same day unless appointed or specifically arranged by the Referee Appointments Sub-Committee. Be punctual and allow enough time to properly make your appointed fixture (arrive at least 90 minutes before the scheduled start of the game for Referees and Assessors) and at least 30min for the Instructors.
- **3.6** Report all on-field and off-field misconduct, recording any necessary information and describing the event as you saw it. All Send-Off and Incident Reports must be submitted no later than 48hr after the end of the match.
- 3.7 Complete all administrative tasks at the conclusion of the match or assignment and to the standard required by ZIFA.
- 3.8 Any unavailability to officiate must be forwarded to the Referee Department in time before the upcoming week fixtures. If, for any reason, you become unavailable for an appointment, notify the Referee Department as soon as possible.
- **3.9** Notify ZIFA of your unavailability to referee any match in accordance with ZIFA 'withdrawal' guidelines.
- 3.10 ZIFA will appoint referees to matches at its absolute sole discretion.



## 4.0 DISCIPLINE

- **4.1** If you witness a fellow Referee/Assessor/Instructor breaching this Code, inform them of the breach they may be unaware. In serious circumstances, report the breach to ZIFA and the Referee Department.
- **4.2** Referee/Assessor/Instructor found breaching this Code or being the subject of a complaint by a colleague or third party may be called upon to explain their actions. If proven, the member may be subject to disciplinary action as decided by the ZIFA Disciplinary Committee.
- **4.3** For the party alleged to have infringed this Code, ZIFA may enforce the terms of this Code and invoke the sanctions only if it has given the party:
  - (a) reasonable details of the alleged infringement;
  - (b) notice of the possible sanctions; and
  - (c) the opportunity to be heard in relation to the issues of infringement and sanction.
- 4.4 The scope and implementation of disciplinary sanctions is as specified in the ZIFA Constitution.
- **4.5** The imposition of a sanction is immediate or as otherwise notified by the party imposing the sanction.



The **Disciplinary Committee** officially constituted by the **Referees Committee** or **the Referees Committee** shall have the right to take disciplinary action against a **Referee/Assistant Referee/Match Commissioner** who has committed any of the following offences:

5.0	Refusing to take up an appointment duly made by the official appointing authority without satisfactory justification.	Four match suspension from officiating official games

Written warning for first offenders and thereafter two match suspension from officiating official games.

17	Being a member or holding position in any Football Club affiliated to the Zimbabwe Football Association.	Member shall be deregistered and banned from officiating indefinitely.

Immediate suspension from any football activities pending an appearance before the ZIFA disciplinary committee.
