ZIFA ELECTORAL COMMITTEE - Election Notice For Vacant Positions

04 February 2026

The Zimbabwe Football Association (ZIFA) Electoral Committee hereby confirms that it is proceeding with the continuation of the December 2025 electoral process to fill all elective positions that remain vacant following the elections held on 6–7 December 2025 and 13–14 December 2025.

These vacancies arise solely from the absence of duly nominated and eligible candidates for certain positions during the initial nomination phase. They are formally declared and remain open for election under the same 2025 electoral mandate.

The continuation elections are conducted in full compliance with the ZIFA Statutes, the Electoral Code and international football governance standards and form an integral part of the 2025 electoral cycle.

Nomination Process

Nomination forms are available for collection from ZIFA Headquarters upon payment in full of a nomination fee. See annexure A.

All completed nomination forms must be submitted to ZIFA Headquarters no later than Saturday, 7 February 2026 at 1400hrs, after payment of the election fees in full. Also see annexure A.

All nominees are required to meet the eligibility, integrity and compliance requirements provided for in the ZIFA Statutes and Electoral Code.

Polling Schedule

The continuation of the elections is being conducted at four designated national polling centres as follows:

- Friday, 13 February 2026 – Gweru
- Saturday, 14 February 2026 – Bulawayo
- Sunday, 15 February 2026 – Masvingo
- Monday, 16 February 2026 - Harare

Only duly accredited voters are permitted to vote in accordance with their respective electoral categories.
